With reference to the above cited subject, as per reference (1) a conditional Fire Safety Recommendation was issued to the premises of at "M/s. Srinidhi Public School, Sy no.48/1, Site no. 20, 21 & 22, A.M Srinivasa Garden, 1st Cross, 3rd Main, Srinidhi layout, Churchaghatta Main road, New Bank Colony, Bangalore-560062.." with a condition to fulfill all the recommendations stipulated in fire safety recommendation and compliance the same within 03 months and as per reference (2) the Fire Safety Compliance Report was issued for the same.

With reference cited (3) above, the management of 'Srinidhi Public School' had requested for the renewal fire safety compliance report from our department. In this regard the above school building was inspected by Fire station officer, Anjanapura on 24-06-2025 to check the compliance of all the recommendations stipulated in fire safety recommendation & on inspection it was found that all the recommendations stipulated in fire safety recommendation has been complied and submit the report as per reference no.04.



Under the above circumstance the Karnataka Fire & Emergency Services Department is issuing the “Fire Safety Compliance Report” to “M/s. Srinidhi Public School, Sy no.48/1, Site no. 20, 21 & 22, A.M Srinivasa Garden, 1st Cross, 3rd Main, Srinidhi layout, Chunchaghatta Main road, New Bank Colony, Bangalore-560062.” subject to proper maintenance of firefighting installations in the good working conditions and arrange for 40% of staffs/ employees training within 03 months from the date of issue of this report.

In case the fire prevention and fire fighting measures installed as per the recommendation of the department are not maintained in good working condition, if the evacuation measures are not properly followed and if any additional construction work is taken up in the building/premises, the renewal fire safety compliance report deemed to be cancelled and necessary legal action will be initiated against the developer/management/tenant and also separate NOC has to be obtained from the department for the storage of Chemicals, Solvents, petroleum products/Explosives, LPG etc., in the premises/building.

“This report is valid for only one year from the date of issue and is renewable without fail”.
